Social Media Campaign by NACG EVAC India

Social media campaign was undertaken by NACG EVAC, India on preventing Child Marriage and combating other forms of violence against children during COVID-19 post lockdown situation and advocating through children, youths and CSOs for promoting safe and protective environment for children. The campaign also focused on contributing to the implementation of National Plan of Action to prevent child marriage.

NACG EVAC, India has been since then active on all its social media platforms like Twitter. LinkedIn, Instagram, and Facebook page. Many awareness content, including videos and posts were developed and posted on a daily basis that attracted more than 6400 followers on our Facebook page. The campaign was able to reach more than 200000 people, more than 150 followers on Twitter and more than 45000 people and 180 followers on Instagram. On LinkedIn, 195 people were connected. It has received more than 1500 impressions on Instagram, and 500 impressions each day on Twitter. People not only followed the handles but also shared the awareness contents and took active part in discussion through comments and messages.

Website Development:

A Website of NACG EVAC India is already developed and will be soon launched and shared with its final look. The website basically contains member details, stories of change from different members, and blogs on recent issues along with home page etc.

The social media campaign during this period along with the website design and development was supported by TDH, NL. National Children Meet



State Level Youth Convention for ending abuse, exploitation, and all forms of violence and torture against children



19th November was observed as the "World day for prevention of child abuse" all over the world with the theme "SDG – Target 16.2 - *End abuse, exploitation, trafficking and all forms of violence and torture against children by 2030 – leaving no one behind*" for the year 2020. To mark the occasion a "State Level Youth Convention for ending Abuse, Exploitation and all form of Violence & Torture against children" was organized on virtual platform by People's Cultural Centre (PECUC). Mr. Satyajit Mohanty, IPS, DG Fire Services was the Chief Guest of the convention. Addressing the convention, Mr. Mohanty said "COVID19 has created a very stressful situation for children.

Around 150 crores of children have been affected by it." Among others Mr. Pradeep Kumar Biswal, IAS (Retd), Ranjan Kumar Mohanty, Secretary PECUC & Chairperson of NACG EVAC, Dr. Minakhi Panda, Chairmen, PECUC, and Ms. Anuradha Mohanty spoke on this occasion. Speakers emphasized to stop all forms of child abuse, exploitation and violence and for this a coordinated action was suggested by all. Stories of Change

Education – as a tool of poverty eradication

Jaga Munda lives with his parents, Babuli and Manjari Munda and two other siblings in Banamahuldiha village, Odisha. His parents work as daily wage earners having very unstable income and it was very difficult on their part to manage their family with the paltry amount they earned. Because of poverty his parents sent him to other villages to work as Bagal (looking after cattle) when he was studying in class 6th. He became a drop out and left school to work and earn to add a little to his parent's income.

Child Club members of PECUC took up this issue at Child Club meeting. The Ward Member along with Child Club members went to Jaga's house and convinced the family to bring Jaga back to his village and put him in the school. His parents agreed and Jaga returned to his village leaving the work in the neighbouring village. On return, he joined Child Club in his village and continued his study in school. Now he is happy

to attend the school and pursue his studies. PECUC believes that education is the vehicle to help poor families come out of poverty. It aims to equip children with literacy and skills that can enable them to gain employment and bring financial relief to their families.

Gardening Addresses Pandemic Anxiety

Seventeen-year-old Kamala* is excited. The seeds sown by her have now blossomed into fresh spinach and fenugreek. It is her moment of pride. Kamala is a victim of child marriage. Early marriage takes a toll on a girl's health, her education is affected and in some cases she is a victim of domestic and sexual abuse. Girls like Kamala are part of an extremely vulnerable and marginalized section of society whose issues are not usually given attention to. The Covid-19 pandemic affects such segments more than the rest. Terre des Hommes Netherlands, Initiatives for Married Adolescent Girls Empowerment (IMAGE) in India constantly strives to provide a better life for early married girls. The project works in vulnerable districts of Karnataka where the prevalence of child marriage is very high.

part of the COVID-19 relief and rehabilitation, one activity was to train these girls in kitchen gardening. A total of 165 girls from 18 villages were provided with vegetable seeds and taught how to plant them in their backyard. This activity kept the girls engaged and proved to be a great stress buster addressing the anxiety and other psychosocial issues arising out of the pandemic which exacerbates their existing vulnerability. The activity also had a dual benefit as it provided the girls' families with a free and sufficient supply of nutritious organic vegetables for consumption, purchase of which would have caused an economic strain due to the loss of livelihoods.



"The gardening activity has helped reduce our stress during the pandemic. We feel confident now that we can produce our own food. We are happy to have learnt a new skill", says Kamala. The girls now plant the seeds of their empowerment, turning a crisis period into an opportune endeavor.

Child Protection Workforce Capacity Building to End Child Sexual Abuse in India

"Child Protection Workforce Capacity Building to End Child Sexual Abuse in India" is a continuing programme with support from World Vision Germany, World Vision India and German Federal Ministry for Economic Development and Cooperation (BMZ) and during this quarter various activities has been undertaken in state of Odisha and Delhi following the guidelines of Governments.

 In Odisha, 270 Village Level Child Protection Committees (VLCPCs) have been formed covering 2715 members from different field like, people's representatives, frontline health workers & ICDS workers. 1107 VLCPC members were trained on management and coordination roles VLCPC, its functions, monitoring, reporting and legal compliances pertaining to CSAE and their accountability.



Block Level Stakeholder's Convergence meeting at Ganjam, Odisha

940 Children were trained on CSAE, child rights, advocacy and respective support mechanisms in both the states, Delhi and Odisha. 868 frontline ICDS & public health workers (ANM, AWW & ASHA workers) were trained on prevention and protection of children

against CSAE. 430 School teachers were trained on CSA, Life Skill Education, POCSO & JJ Act and Child Protection systems in schools across Delhi and Odisha.

- In Delhi 42 nos. of Police / SJPOs were oriented through virtual platform on laws, policies, SoP compliances, monitoring and accountability for CSAE. 250 nos. of Block level stakeholders and CP Service Providers were oriented on implementation of the POCSO Act and JJ Act to facilitate wider collaboration and convergence among them for effective implementation of policies and laws for protection of children in Delhi and Odisha.

State Level Children's Consultation on Prevention of Child Sexual Abuse and Exploitation in Odisha and Delhi

 A State Level Children's Consultation on Prevention of Child Sexual Abuse and Exploitation was organised on 29th & 30th December, 2020 at Panthanivas, Bhubaneswar. 51 adolescents (30 girls & boys 21) from 7 districts of Odisha participated in this consultation. The key objective of the event is to provide space to the children and encourage them to participate and express their views/concerns, being active citizens of the country. Mr. Ranjan Kumar Mohanty, Secretary, PECUC, Ms. Anuradha Mohanty, Executive Director, PECUC, Ms. Madhumita Dash, Senior Consultant UNICEF, Mr. Manoj Tripaty, Senior Consultant, Dr. Mitali Mohanty took different sessions in this consultation.




A state level consultation held in Delhi on 29th and 30th of December. 107 children participated from all over the district of Delhi. In this consultation 9 children (72 children in total) were gathered at a place in their district individually and remaining 35 children of 3 districts united at a center place arranged. Each district then united virtually with all the facilities to make the communication smooth. Mr. Ranjan Kumar Mohanty, Chairperson, NACG EVAC India, also spoke to children in this occasion. Mr. Ashok Kumar from A.V. Baliga memorial trust oriented the children about UNCRC and Sustainable Development goals and how UNCRC and SDG are working against CSAE.



Children were briefed about life-skills and the children prepared scorecard in which they talk about issues related to child protection and CSA. A manifesto was prepared to share with government stakeholders on behalf of the children participated during this consultation.
