International Year for the Elimination of Child Labour

Year 2021 is being observed as International Year for the Elimination of Child labour (IYCL). In the year 2019, The United Nations General Assembly (UNGA) unanimously adopted a resolution declaring 2021 as the International Year for the Elimination of Child Labour. In recent year substantial progress has been achieved towards elimination of child labour. This happens largely because of intense advocacy and national mobilization backed by legislative and practical action. But still there is more than 152 million children are in labour globally. The International Year for the Elimination of Child labour (IYCL) is an opportunity to strengthen the efforts to achieve the global target to end child labour by 2025. agreed as the Sustainable development Goal Target 8.7. The International Year for the Elimination of Child labour (IYCL) was launched by Alliance 8.7 on 21 January 2021, under the banner: Act – Inspire – Scale Up, with a global call for action pledges to end child labour by 2025.

The COVID19 pandemic has made the challenge of eliminating child labour by 2025 even harder. Since the schools are closed, children are at risk of being pushed into child labour due to the COVID19 crisis. Child labour harms children mentally, physically, socially and morally. It interferes with their schooling, preventing them from attending or concentrating. The joint initiative encourages regional, national and organizational stakeholders and individuals to indentify concrete actions that they will take by December 2021, to help end child labour. Lets come together and act now for eradication of child labour in all forms, factors & processes.

National Consultation & Convergence Meeting to End Child Sexual Abuse



Two days of National Consultation & Convergence Meeting to End Child Sexual Abuse in India was inaugurated at Puri on 13th March 2021. This was organized by National Action and Coordination Group for Ending Violence Against Children (NACG-EVAC), India, the country level civil society forum of SAEIVAC, an apex body of SAARC in collaboration with World Vision, Germany, WVI & German Federal Ministry for Economic Cooperation and Development (Bundesministerium fur wirtschaftliche Zusammenarbeit and Entwicklung).

The objective of this Consultation was to develop a platform for CSOs and other stakeholders to share the Child Protection challenges and good practices to prevent Child Sexual Abuse and Exploitation, and also collaborating with various stakeholders to review and firm up the strategy to end Child Sexual Abuse with involvement of all stakeholders related to child protection issue as stated by Mr. Ranjan Kumar Mohanty, Chairperson of NACG EVAC India .Justice DP Chowdhury, Former Judge, Orissa High Court & President, State Consumer Disputes Redressal Commission addressed the participating members, and emphasized on the role of Civil Society members to create awareness on rights of the child and the ways in which they can claim it. He also adds that participation of children to voice their needs is the first step to ensure they are empowered and protected.

Dr. Rinchen Chophel, Director General of SAIEVAC, connected through virtual platform said that it is the right time we must start protecting

children focusing on issues related to the child sexual abuse mainly during the pandemic. Mr. Mikhael Pradhan, World Vision India said, Child sexual exploitation is a serious issue and its magnitude is high, which demands a concerted effort by all the stakeholders to work together. Mr. Yashwant Jain, Member, National Commission for Protection of Child Rights (NCPCR), expressed his deep concern over rising incidents of child sexual abuse. He also highlighted that there is a greater need to reach out to children, school, and community to create awareness on the POCSO Act to help them understand the gravity of the penalty under the Act. Ms. Sandhyabati Pradhan, Chairperson, OSCPCR, shared about the initiatives taken by the government of Odisha and OSCPCR in preventing child sexual abuse and applaudedthe work of NACG-EVAC India for the cause. Mr Sanjay Mishra, Treasurer of NACG EVAC India gave vote of thanks to all the speakers for their valuable inputs. Among others Ms. Vidya Reddy, Director Tulir, Mr. Barun Pathak, Advocate Supreme Court, Mr. D. Roshan Kumar, Vice-chair, NACG, Dr. Indrani Bhattacharyya, Mr. Parha Das, Plan India, Dr. Abhaya Kumar Mallick, Dy. Director, Elementary Education, Govt. of Odisha, Dr. Anangdev Singh, WVI, Mr. Subrat Kumar Panda, TdH, NL, Ms. Aditi P. Kaur, E.C Member, NACG India also spoke on the occasion.

14th March 2021, the 2nd day of National Consultation & Convergence meeting was held at Puri to end child sexual abuse in India. This was organized by NACG EVAC.

The consultation brought out many challenges as well as recommendations from the stakeholders. Sharing on the incidences of violence against children covering Odisha and Delhi, Mr. Mikhael Pradhan, Head Advocacy, World Vision India said that most of the children are ignorant of child protection related laws to make best use of them for their own protection. Children have reported online abuse and child marriage cases.

Dr. Rashmi Singh, Director WCD, Govt. of Delhi expressed her deep concern on the issue, emphasized on importance of promotion of culture and tolerance on any sort of exploitation on children. She suggested better alignment between different institutions and departments to work jointly in order to ensure application of laws. Holistic approach needs to be adopted to address this serious issue. She also spoke on the violence against children at home that needs safety audit. Senior Police Officer, Mr. Sudhansu Sarangi, IPS, sharing his perspective on the issues said security of child is not exclusive responsibility of police, rather social relationships both within the

family and within the neighborhoods provide a greater safety net to the children. Yashabanti Sreemany, Member West Bengal SCPCR said use of WhatsApp to lodge complain on several exploitation increased the number of cases and the response was quick. She said that the best practice of reaching out to wider audience was possible through capacity building of stakeholders. Speaking on the occasion, Ms. Nidhi Dwivedi, Member of DSCPCR, Delhi said best use of special relief fund, promotion of smile club, coordination between different departments has resulted in a positive impact. Mr. Preetikant Panda, Programme Manager of OSCPS shared the initiatives of the government of Odisha focusing on child abuse prevention, such as full time workforce in child protection system.



During the concluding session, Dr. Rinchen Chophel, Director General of SAIEVAC said that it is an effort of NACG EVAC India to converge and collaborate with relevant suggestions and recommendations from civil society organisations, ministries, commissions, departments, CSOs and other key stakeholders to come out with strategies in preventing CSAE. He also suggested that child sexual abuse can be prevented in a collaborative effort.

NACG EVAC India National Board Meeting



The board meeting of NACG EVAC, India was held on 15th March 2021 at Puri, Odisha. NACG EVAC India has decided to start a country wide massive campaign for combating Child Sexual Abuse in India. The National Board which met here on third as a follow up of National Consultation and Convergence meeting to end child sexual abuse in India, discussed various recommendations and suggestions and came out with a strategy for various activities for the campaign. NACG EVAC India National Board members from 17 states participated in the meeting. Shri Priyank Kanoongo, Chairperson, National Commission for Protection of Child Rights, graced the meeting with his presence to take cognizance of various issues faced by children across the country. Mr. Ranjan Kumar Mohanty, Chairperson, NACG EVAC India presided over the meeting. Mr. Sanjay Gupta, Vice Chair Person, NACG EVAC India introduced the aims and objectives of the NACG EVAC India in ending violence against children.

Mr. Kanoongo officially released the NACG EVAC India Charter in the National Board meeting. Mr. Ranjan Kumar Mohanty said that the Charter of NACG EVAC India is first of its kind amongst the NACGs of SAIEVAC member countries.



Various suggestions and recommendations that elicited out of these two days consultations were presented to the Chair, NCPCR, for e.g., formation of village level Child Protection Committees, violation of rights of migrant children, addressing the issue of tribal customary practices, child labour issues & exploitation of children in Brick kiln industries.

Shri Priyank Kanungo took cognizance of all issues and assured the Commission's support to address these issues and demanded support of the NACG EVAC India as well. Shri Kanungo mentioned about the initiatives taken by the Commission to conduct social audits in 7000 children care institutions. He also mentioned the significant initiative taken by the Commission for the digitalization of CCI monitoring and inspection data that will be uploaded in the Monitoring App for Seamless Inspections (MASI) App for monitoring and compliance of CCIs with JJ Act, 2015 and JJ Rules. He also highlighted the POSCO cases in the country.

Mr. Sanjay Mishra, Treasurer NACG EVAC India, emphasized that collaboration with NACG EVAC India at state level, as well as collaboration between NACG EVAC India and NCPCR will pave a way to a stronger partnership model to end violence against children in India.

She gave importance on the moral responsibility of all working in different areas like govt., civil society, schools and private sector to be vigilant in reporting the cases and creating awareness. The system at District, State and Panchayat level needs to be more active and focused regarding reporting of CSA.

Delhi State Consultation on Convergence and Coordination amongst Stakeholders at Delhi



Delhi state level Consultation on Convergence and Coordination of Stakeholders was organised at India International Centre, Lodhi Road, New Delhi to deliberate on ending Child Sexual Abuse and Exploitation and ending all forms of violence against children in Delhi. 92 delegates representing the Government of NCT of Delhi, Department of Women and Child Development, the Delhi Commission for Protection of Child Rights (DCPCR) and CSOs participated in the consultation, comprising of CWC members, District Child Protection Officers (DCPOs), Superintendent and welfare officers from CCIs, Protection officers and Civil Society Organisation members.

The consultation was organised by People's Cultural Centre, Bhubaneswar, Odisha in collaboration with National Action and Coordination Group for Ending Violence Against Children (NACG-EVAC) India with support of Department of Women and Child Development (DWCD), Delhi. The other partners in the event were World Vision India, World Vision Germany, German Federal Government in partnership with ABHAS, AV. Baliga Memorial Trust, Asha Deep Foundation & Society for Participatory Integrated development (SPID-Society), New Delhi.

Addressing the inaugural session, Dr. Rashmi Singh IAS, Special Secretary cum Director (Social Welfare) and Director, Department of Women and Child Development, Govt. of NCT Delhi voiced that through collective ownership and shared accountability proper care and protection can be provided to children against sexual violence.



Mr. Ranjan Kumar Mohanty, Chairperson, National Action and Coordination Group for Ending violence against children (NACG- EVAC-India), highlighted about the aims and objectives of NACG EVAC India CSO Network. The NACG EVAC India brings together the NGOs networks, coalitions, media, children's forums, academia and other civil society bodies for interaction, networking, joint advocacy, sharing of good practices and experience to end all forms of violence against children especially Child Sexual Abuse, Child Trafficking, Child Labour, Child Marriage and Corporal Punishment with integral focus on Children living with Disability and Child Participation.

Mr. Mikhael Pradhan Head-Advocacy, World Vision India shared about the aims of the BMZ-NACG EVAC India Capacity Building Project and objectives of the Convergence and Coordination meeting organised for the child protection stakeholders and service providers.

Ms. Madhvi Samson, State Convenor, NACG-EVAC India highlighted that generating awareness on CSA among children, parents/caregivers and in the society is the need of the hour and of high importance and an important weapon to curb child sexual abuse especially in Delhi. Mr. Anurag Kundu Chairperson, DCPCR focused that bringing right stakeholder or actors together in one platform and their collective action would bring impact in the community to control child sexual abuse.

In the concluding session Ms. Madhu K. Garg Secretary, Department of Women and Child Development, Govt. of NCT Delhi highly appreciated the effort of bringing the nodal departments and functionaries e.g. DWCD, DCPCR, CWCs, CSOs to a common platform through the convergence meeting. She thanked NACG EVAC India for the initiative to promote for the child protection.

Some major recommendation emerged out of the consultation are to take immediate cognizance of the sexual violence against children in Delhi, importance and effective implementation of the JJ Act and POSCO Act with true spirit and essence, fast track the trial and justice dispense system, mental health and psycho-social care and support to survivors, strengthening the prevention mechanism to safeguard children against sexual violence, the need of periodic convergence and coordination meeting among various stakeholders for prevention, protection, rehabilitation and re-integration of children etc.

News from States

Nutritional Support to Children with Disabilities in Puri by OLS and Tech Mahindra Foundation

In order to reach out to the unreached, OLS with support from Tech Mahindra Foundation supported dry ration to 500 families having person with disability which are in distressed condition and finding it difficult to cope up with the situation in the slums of Puri Municipality.

OLS procured the materials from Santrupti, a Self Help Group of women with and without disabilities. The first batch of distribution started 13th February



2021 at Akhyayadham Community Hall followed by BalinoliaSahi where the Councilor was present and also Mr. Rashmi Ranjan Mohanty, CSR Coordinator, Tech Mahindra Foundation, Bhubaneswar. The distribution was completed in a phased manner between 13th and 22nd February 2021. Each family received a packet containing the items, i.e. Rice- 10 kgs, Flattened rice- 10 kgs, Jaggery- 5 kgs, Raw Groundnuts- 2 kgs, Gram Dal- 1 kg, Mustard oil- 1 kg.



"The struggle for food has been a long drawn battle for this fishermen community who were restricted by the pandemic to venture out to the sea for their livelihood. It brought untold miseries to the families especially those having children/adults with disability. The timely support by OLS and TMF cannot be praised enough. Unprecedented Times Call For Unprecedented Actions

Foster Parenting Helped Us!

The Corona virus proved to be a real challenge. The lockdown was a dampener and a shocker for everyone. When everyone was leaving the campus on

21 March, little did anyone know that things were going to drastically change.

The academic year had just ended and planning for the new session was going on but everything came to a naught. The education process shifted online and educators had to radically change their thought process to adapt to the new situation. Classes started in the first week of April as they would have otherwise. Everyone was putting in their best efforts but there were challenges, especially for the economically disadvantaged group. Education and classes did not remain a priority for a few. Parents had lost their jobs and the situation was grim. The lockdown started easing in May and St. John's High School got into action. The first challenge was to reach out to our vulnerable little ones.

St. John's has an extremely dedicated FOSTER PARENT program. Each staff member is responsible for the well being of two/three EDG students and personally gets involved with them. The foster parent took special care of his/her foster sons during this terrible period of isolation and kept a close watch and could identify their needs.

- 1. **Distribution of learning material**: Sets of books, copies, etc were distributed in COVID affected colonies like Bapudham, where most of the students belonged to.
- 2. **Distress calls** were coming in from students who had financial problems and ration was provided to them.
- 3. EDG students also had a problem because of the non availability of smart phones. The Principal, Mrs. Kavita Das requested help from the alumni group, SJOBA (Batch of 1977) and in a short period, 40 of the students received smart phones which enabled them to start attending classes regularly. This really made a difference as they were up to speed with the rest of the class.



THE AIM WAS TO LEAVE BEHIND NO ONE and not even one family had to leave Chandigarh because of lack of facilities.

Students were feeling disconnected with the school and missing all the fun and activities that they used to have in school. Various online competitions were organized to cheer them up and the participation was encouraging. Earth day, Bio diversity day, Teachers Day, all occasions became online celebrations. The school encouraged students to thank the frontline warriors by making cards and reaching out. All through, students were kept engaged through interactive games, songs, individual research projects, activities around art, PE, music, yoga, dance and drama as well.

As the situation eased, and students became more settled, they were involved in outreach programs. Online yoga, English speaking sessions were held during these outreach sessions with the outreach partners. This inculcated the quality of acceptance and mutual respect.

An outstanding effort was put in by Class 6 students who made videos of X-mas carols in sign language for hearing impaired students of Vatika Special School.

Then X-mas rolled in which is the yearly giving time for Johnians. The regular program, A FISTFUL OF RICE was initiated and students and their families opened their hearts and collected 1000 kgs of grains to donate to the Langars in PGI, Sector 32 GMCH and Mansa Devi all services were providing food for families of patients. It was a difficult time for everyone and these little rays of hope were bringing in light for some.

Celebrating the Girl Child

"As Priya reached the finish line of the 200 metre race, she jumped with joy; the sparkle in her eyes reflecting her victory. True, she beat the others in this athletic contest but what she accomplished to defeat was much more — a life caught in the clutches of despair. Priya is a victim of child marriage. In India, around 1.5 million girls like Priya are forced to get married before the age of 18 every year, facing severe health issues, domestic abuse, and lack of education. Their childhood is lost behind the ugly viel of this social issue."



TdH-NL's Initiatives for Married Adolescent Girls' Empowerment (IMAGE) project empowers early married girls and fights against child marriage. On the occasion of the National Girl Child Day in India on the 24th January this year, the project decided to celebrate the victory of these girls. To observe the day, IMAGE conducted a sports day programme in Karnataka which saw the participation of 6 early married girls, 15 Kishoris (vulnerable adolescent girls) and the IMAGE staff.

When Children of Devadasis dialogue with the Government



A two day event was organized by TdH-NL's Children GOOD project at Bangalore, on 28th and 29th January 2021. Children of Devadasis along with their mentors, from Bijapur, Koppal, Bagalkot, Bellary and Belgaum districts, participated in the event. The goal of the event was to let these children

present their issues in front of the Government officials, for an action to be taken against injustice meted out to them. Coming from a poor socioeconomic background where they face exploitation, this event was a great opportunity for them to seek redressal. The children prepared a list of their issues such as Strict action against harassment and sexual assault on devadasi children, change in application process to ease their continuation to higher education, and special reservation for devadasis in jobs and presented before Dr. Shashidhar Shetty, Head of Karnataka State Legal Services Authority, Mr. Anthony Sebastian, Head of Child Rights Protection Commission, and Ms. Asha Ramesh, Head of Women Development sector were present in this event. The children were highly motivated and hailed as "Seeds for Change" by the panel.

Income Generation during the pandemic

In the Mica belt of Jharkhand, India, most of the families are dependent on Mica scraps for their livelihood. The whole family including children work in these mines as a means to ensure their survival. This leads to children dropping out of school and helping their parents in extracting mica.

As part of TdH-NL's Mica project to eradicate child labour in the mica industry (Koderma and Giridih, Jharkhand), TdH-NL provides these families with access to a community revolving fund which they further invest in additional income generation activities, such as agriculture, goat rearing, tailoring and so on. The IGA became the primary source of income for some families during the pandemic. During January and February, 757 families were given facilitated access to income generation activities and a total of INR 3,15,500 was collected as a repayment from 119 SHGs.

Training early married girl as change agents



As part of empowering early married girls, TdH-NL is working towards building a movement of these girls where they would be capacitated to stand up, advocate and fight for their rights and get their demands met. In lieu of this, early married girls displaying confidence and good communication skills were selected as leaders of this movement. The 53

leaders who attended the workshop in Belagavi district of Karnataka were refreshed and regenerated to continue advocating against Child Marriages. The workshop also gave the leaders the knowledge about the Government Welfare Schemes with respect to Early Married Girls and how the movement leaders can further share this knowledge with their small groups. Overall, the Movement Leaders highly benefited from this and were extremely enthusiastic to be agents of change in their communities.

The consultation was organized by National Action & Coordination Group for Ending Violence Against Children (NACG EVAC), India, PECUC (Secretariat), OLS (Odisha Convenor), World vision India & Germany in collaboration with Odisha State Commission for Protection of Child Rights (OSCPCR). Mr. Prakash Rath, Convenor NACG EVAC India, Odisha Chapter gave the welcome address and Mr. Ranjan Kumar Mohanty, Chairperson NACG EVAC shared the vision, mission of the project and objective of the convergence meeting as well.

Participating in the consultation Ms. Sandhyabati Pradhan, Chairperson, OSCPCR, said that most of the children are ignorant of child protection related laws to make best use of them for their own protection. Mrs. Kasturi Mohapatra, Chairperson of OSCPCR expressed her deep concern on the issue, emphasized on importance of promotion of culture and zero tolerance on any sort of exploitation and abuse of children. Mr. Sanyashai Behera, OAS, DSSO, SSEPD Deptt. sharing his perspective on the issues said security of child is not exclusive responsibility of police, rather social relationships both within the family and the neighborhoods provides a greater safety net to the children. Former OSCPCR member Harihar Nayak presented data from National crime record bureau.
