#### **ABOUT NACG EVAC INDIA**

National Action & Coordination Group for Ending Violence Against Children, India (NACG- EVAC India) is a country-level civil society forum of the South Asia Initiative to End Violence Against Children (SAIEVAC) with a vision that all children irrespective of gender, throughout South Asia enjoy their right to an environment free from all forms of violence, abuse, exploitation, neglect & discrimination. NACG EVAC India is the only network of relevant civil society organizations that represents actors from all the states and thus becomes a truly National-level network.

The NACGs are constituted by child rights organizations including entities that promote children's rights and have a pivotal role in coordinating the EVAC agenda of SAIEVAC at the National level, particularly with the SAIEVAC Government mechanisms. The NACGs have a regionally defined and customized country-specific governance structure. This network, through its long-standing expertise and experience, is in a good position to implement the planned project activity.

The four guiding principles of NACG EVAC India are non-discrimination: devotion to the best interests of the child; the right to a dignified life, survival, and development; and respect for the views of the child. Currently, NACG- EVAC India has its presence across 21 states and 4 Union Territories, accomplished through the concerted efforts of state convenors and dedicated members. operate under the governance of the Executive Committee (See details at Page 6) and its office bearers, however the entire network functions under the leadership of its chairperson.

I am delighted to present the latest updates and accomplishments from the NACG EVAC India through this newsletter.

First and foremost, I extend my deepest gratitude to all our dedicated members whose tireless efforts drive our mission of preventing and addressing all forms of neglect, abuse,

exploitation, and violence against children. Your unwavering commitment and passion are the cornerstone of our success.

Over the past year, NACG EVAC India has made remarkable progress in safeguarding and empowering children nationwide. Through our diverse programs and initiatives, we have strived to create safe and nurturing environments where children can thrive and realize their full potential.

In the process of strengthening our network, we have connected with 1248 personnel, including NGOs, government officials, and policymakers across different states. Additionally, through 12 online meetings and events, we engaged with over 1025 individuals. We also successfully conducted a new membership drive, welcoming 429 new members to NACG EVAC India.

Our state chapters have been active in organizing various online and offline state chapters meetings. These gatherings saw the participation of more than 580 individuals who came together to discuss action plans for their respective states. Sincere efforts were made to work in collaboration with various renowned organizations on different themes. Through these partnerships, we have reached 14 states, including Jharkhand, Gujarat, Andhra Pradesh, Bihar, Jammu and Kashmir, Madhya Pradesh, Odisha, Delhi, Nagaland, Uttarakhand, Tamil Nadu, Telangana, Assam, and West Bengal. We organized consultations in these states, with a total of 739 children participating both online and offline, reaching over 1850 individuals. Additionally, a National Consultation has been organized in Kolkata to share the best practices adopted in these states.

I extend my heartfelt appreciation to all our partners and donors whose invaluable support has been pivotal in our achievements. Together, we are effecting tangible change in the lives of countless children.

# NACG-EVAC INDIA COLLABORATES WITH THE GOVERNMENT OF HARYANA TO STRENGTHEN CHILD PROTECTION SYSTEM





In a concerted effort to fortify the child protection system in Haryana, the National Action Coordination Group to End Violence Against Children (NACG- EVAC) India, Haryana Chapter, joined forces with the Department of Women and Child Development, Government of Haryana, for a State-Level Stakeholder Consultation held at the Haryana Institute for Public Administration on 4th of July 2023.

The consultation kicked off with a warmwelcome from Ms. Gurpreet Kaur, the State Convener of NACG-EVAC India, who outlined the purpose of the event. Mr. Sanjay Gupta, chairperson NACG EVAC India, provided insights into the group's objectives, and Mr. B.K. Goel, a National Board member NACG EVAC India, addressed critical issues affecting children in Haryana.

Chief Guest Smt. Monica Malik (IAS), Director of Women and Child Development, stressed upon the need for a unanimous effort to safeguard children's rights.

Participants discussed challenges such as adoption delays, biased mindsets affecting collaboration, documentation problems for slum kids, and concerns related to Dark Net and cyber security.

The session delved into access to various schemes, providing valuable information on child-centric initiatives and education department facilities.

Key discussion included addressing the ban on NGOs' entry into schools, clarifying the age limit for specific schemes, seeking more clarity on the POCSO act, and confirming no Aadhaar card requirement for school admission. Representatives from various CSRs engaged in a discussion on CSR laws,

bridging the gap between corporates and NGOs, role of social workers and front-line workers in CSR teams.

The consultation yielded key takeaways, emphasizing the importance of generating awareness about government schemes, strengthening government systems through shared information and ideas, and providing a platform for stakeholders to discuss challenges and find solutions. Mrs. Chandralekha Mukherjee, Director General of the Haryana Institute of Public Administration, appreciated the consultation's impact, agreed to its frequency, and highlighted the importance of addressing anxiety and mental illness.

This collaborative effort between NACG EVAC and the Government of Haryana marks a significant step toward ensuring the well-being and protection of children in the state.

# SUCCESSFUL STATE CHAPTER MEETING OF NACG EVAC INDIA ODISHA CHAPTER

# MOBILIZATION OF STAKEHOLDERS TO COMBAT CHILD LABOUR THROUGH CONSULTATION ON COLLABORATIVE EFFORTS TO END VIOLENCE AGAINST CHILDREN





In a landmark collaborative effort, the National Action Coordination Group to End Violence Against Children (NACG EVAC India) convened a crucial stakeholder consultation at the India International Centre (IIC) to address the pervasive issue of child labour. The meeting, held on July 26, 2023, brought together a diverse array of stakeholders, including government representatives, NGOs, legal entities, academicians, children, and the media personnel.

Mr. Sanjay Gupta, the chairperson of NACG EVAC India, set the stage by outlining the NACG EVAC India's objectives, focusing on thematic issues such as Child Labour, Child Marriage, Child Trafficking, Corporal Punishment, Child Sexual Abuse, and Exploitation. The meeting was marked by Mrs. Madhavi Kotwal Samson, State Convenor NACG EVAC Delhi Chapter, who initiated discussions referencing a recent child labour case in Dwarka, Delhi.

The stakeholders delved into crucial topics, emphasizing the need for a common National Child Protection Policy. Discussions also

revolved around the active involvement of Resident Welfare Associations (RWAs) in reporting such cases to the police. The meeting underscored the vigilant role of local Child Protection Committees.

Representatives from various organizations shared valuable insights and recommendations. Mr. Varun Pathak from the Child Welfare Committee highlighted the sensitivity of the issue, while Mr. H.K. Chetty from the Ashadeep Foundation stressed the importance of amending implementing the National Child Protection Policy. Mr. Vishwajeet Ghosal from Prayas NGO emphasized the need to involve RWAs and community members in raising awareness about child labour norms.


Ms. Naseem Khan from Cequin, shed light on the evolving challenges of child labour due to technological advancements and social media, stressing the importance of differentiating child labour in various contexts.

Participants discussed the need for a trade union policy, drawing inspiration from successful practices in different countries. Ms. Itishree from the Asia Regional Child Labour Project shared insights from these countries, where scouts and RWAs actively raised awareness and identified houses without child labour. Lawyer, Mr. Anant Kumar Asthana highlighted the 2021 amendments to the labour code, suggesting specific points for discussion with the government.

Participants stressed the importance of understanding the root causes of child labour, reviewing existing policies, and bridging the gaps between policies and their implementation. The meeting emphasized the necessity of a district child protection policy, creating awareness at the ground level, and engaging RWAs in the process.

In conclusion, the stakeholder consultation underscored the urgency of addressing child labour through collaborative efforts, policy advocacy, and the active involvement of various stakeholders at different levels. The commitment of diverse stakeholders reflects a collective responsibility to end the menace of child labour and ensure a safer future for the nation's children.

# "NATIONAL CHILD SAFEGUARDING POLICY REVITALIZED: A UNITIED EFFORT FOR INCLUSIVE PROTECTION"



On August 8, 2023, in a comprehensive online meeting of the NACG EVAC India and various organizations collaboratively worked to reshape the National Child Protection Policy established in December 2018. Led by Mr. Sanjay Gupta NACG EVAC chairperson, the meeting produced a multitude of insightful suggestions aimed at enhancing the policy's efficacy. Recommendations ranged from altering the document's title to "Child Safeguarding" for greater inclusivity,

refining definitions of key terms, and expanding the policy's scope to encompass diverse institutions, including religious ones, hostels, and even restaurants. Notable additions included addressing mental and emotional issues, specifying jurisdictional extents, incorporating state commitments akin to Karnataka and Madhya Pradesh policies, and ensuring gender inclusivity throughout the document.

The vision and mission sections were emphasized for more clarity, with a call


to define categories of children based on the Juvenile Justice Act and a focus on the UN Convention on the Rights of the Child (UNCRC). The guidelines proposed separate documents for policy and guidelines, meticulous operationalization, clear terminology explanations, and comprehensive redressal policies. Recommendations extended to include children's voices, cyber-crime considerations, and the safeguarding of children affected by the tourism industry.

Additionally, the need for regionspecific policies, implementation at various organizational levels, coherence with legislation, detailed monitoring and evaluation processes were underscored. The annexure section saw calls for an elaborated declaration, definitions, and terms, as well as commitments from institutions and organizations. This collaborative effort signifies a significant step toward reinforcing protection nationwide, acknowledging diverse vulnerabilities, and ensuring the policy's adaptability to evolving challenges.

# NACG EVAC INDIA MADHYA PRADESH CHAPTER GOT ESTABLISHED AND CONVENED ITS FIRST MEETING

In a significant development, the National Action and Coordination Group for Ending Violence against Children (NACG EVAC), Madhya Pradesh Chapter conducted its state meeting on October 12, spearheaded by Mrs. Archana Sahay, State Convenor.

With a focus on efficiency, members discussed the need to create sub-committees to address key issues. Proactive steps were taken to ensure a strategic approach to problem-solving. Members delved into crucial topics, emphasizing the importance of addressing cross-cutting issues such as education and child sexual abuse. The discussions aimed at formulating comprehensive



strategies for effective intervention.

## RETHINKING AGE OF CONSENT FOR THE WELL-BEING OF GIRLS - A SPECIAL WEBINAR ON INTERNATIONAL DAY OF THE GIRL CHILD

The webinar, "Age of Consent in the Best Interest of Children," convened on 11 October 2023, marked the occasion of International Girl Child Day. The event was organized by the Campaign against Child Marriage (CACM) in collaboration with NACG EVAC India under the aegis of SAIEVAC, reflecting a concerted effort to address legal nuances surrounding the age of consent and their impact on children.

Prof. DP Verma, Member of the Law Commission of India, delivered a compelling keynote, emphasizing the significance of the recently released Law Commission of India Report No. 283. Dr. Rinchen Chophel, Director General at SAIEVAC distinguished representative from the UNCRC, provided a global perspective on child rights and their intersection with the legal frameworks discussed. Mr. Sanjay Gupta, Chairperson of NACG EVAC India, and Dr. Vikram Srivastava, Advocate and Founder of



Independent Thought, moderated a dynamic discussion. The conversation delved into nuanced aspects of the Law Commission's recommendations, the interplay with existing legislations such as PCMA and POCSO, and strategies for effective implementation.

The webinar provided a comprehensive platform for legal experts, scholars, practitioners, and activists to engage in a meaningful dialogue on age of consent laws and their implications on children's well-being. As the event aligned with International Girl Child Day, it underscored the collective commitment to ensuring a secure and supportive environment for children in South Asia. The insights shared by the distinguished speakers and moderators will undoubtedly contribute to ongoing discussions and efforts aimed at ending violence against children in the region.

# DEVELOPING UNDERSTANDING ON UNCRC FUNCTIONS AND SAIEVAC

On November 4th, NACG EVAC India organized a dialogue with Dr. Rinchen Chophel, Director General SAIEVAC and Vice Chair of UNCRC committee and Mr. Sanjay Gupta, discussing how both UNCRC and SAIEVAC can connect with NACG EVAC to aid at the ground level. Dr. Rinchen Chophel explained about UNCRC, the United Nations Convention on the Rights of the Child, serves as a comprehensive international treaty outlining children's civil, political, economic, social, and cultural rights, ensuring fair treatment and access to their entitlements. SAIEVAC, the South Asia Initiative to End Violence



Against Children, offers a platform for South Asian countries to exchange experiences and develop strategies

to combat various forms of violence faced by children in the region. He added that both frameworks are crucial in upholding children's rights, collaboration fostering between governments and organizations to create safer environments for children to thrive. It's imperative for society to uphold these commitments and work towards a world where every child can live free from violence and discrimination, recognizing the moral imperative alongside the legal framework provided by UNCRC and SAIEVAC. In last he ensured that SAIEVAC and UNCRC are keen to work in collaboration with NACG EVAC India. Dr. Rinchen Chophel from SAIEVAC, representatives from Terre des hommes, and UNICEF India, extended their support to the efforts undertaken by the NACG-EVAC Tamil Nadu Chapter.

Themeeting exemplified a significant stride towards fostering collaboration, sharing expertise, and collectively working towards the common goal of ending violence against children. The resolve of the NACG-EVAC Tamil Nadu Chapter reflects a united front in addressing this critical issue on both state and national levels.

### NATIONAL CONSULTATION ON SUSTAINABLE DEVELOPMENT GOALS- SPOTLIGHTS INDIGENOUS WOMEN AND GIRLS' ACCESS TO WATER & SANITATION

On 25th July Mr. Sanjay Gupta Chairperson NACG EVAC India participated in a National consultation on significant steps towards fostering dialogue on Sustainable Development Goals (SDGs) and amplifying the voices of Indigenous Women and Girls, at Nagaland House, R.K.Puram, New Delhi. The event was organized by Sisterhood Network and supported by Ms. Azungla James, Director of Sisterhood Network and National Board Member of NACG EVAC India, Nagaland Chapter.

The consultation drew the participation of over 25 members, creating a vibrant platform for discussions on the crucial topic of water and sanitation accessibility for Indigenous Women and Girls. The event shed light on the challenges faced by these communities in achieving SDGs related to water and sanitation and emphasized the need for targeted strategies and interventions.

Ms. Azungla James, shared that her oraganasation Sisterhood Network, played a pivotal role in orchestrating the event. Her vision for inclusivity and empowerment was

evident throughout the consultation, fostering an environment conducive to meaningful conversations and shared insights.

Various experts, activists, and community leaders engaged in fruitful discussions, sharing experiences and best practices to address the unique challenges faced by Indigenous Women and Girls in accessing water and sanitation facilities. The exchange of ideas aimed at developing and achieving sustainable solutions, and advocating for policies that prioritize the needs of these marginalized communities.

### TRIPURA STATE CHAPTER UNVEILS AMBITIOUS PLANS VIA MEETING

In a proactive move towards safeguarding the rights of children, the NACG EVAC Tripura State Chapter convened a crucial meeting on October 15, 2023.

The meeting presided over by Tripura State Convener of NACG EVAC Dr. Sreelekha Ray, saw active participation not only from existing members but also welcomed representatives from various other organizations dedicated to child welfare. The meeting kicked off with a comprehensive discussion on the five thematic areas outlined by the NACG - EVAC Child Marriage, Child Labour, Corporal Punishment, Sexual Abuse and Exploitation, and Child Trafficking.

Following the in-depth deliberation on these critical themes, the NACG EVACTripura State Chapter unanimously decided to join forces for the "Child Marriage Free India Campaign." The campaign is set to unfold on October 16th and 18th, 2023,



across all eight districts of Tripura. Given Tripura's second position in the country regarding child marriage, the commitment extends to a year-long initiative dedicated to preventing child marriages.

Addressing the current membership scenario, with only seven organizations onboard, the meeting resolved to actively

work towards expanding the Tripura State Chapter. The ambitious target is to enlist a minimum of two members from each district, in-total at least sixteen new members within the next three months. While simultaneously addressing other thematic issues, the primary focus will remain on the "Prevention of Child Marriage."

### WEST BENGAL STATE CHAPTER ORGANIZED A STATE-

**LEVEL SYMPOSIUM IN KOLKATA** 

Under the dynamic leadership of Mr. Manabendra Nath Mondal, convenor NACG EVAC West Bengal state chapter, a collective effort has been initiated to address critical issues related to child welfare. The event successfully brought together 40 dedicated members from 10 districts of West Bengal. These members, equipped with in-depth knowledge on the theme of Ending Child Marriage, collaborated to establish a more structured approach in support of the national objectives set by the NACG EVAC India.

The primary focus of the event was to tackle pressing issues such as Child Marriage, Corporal Punishment, Sexual Abuse and Exploitation, Trafficking, Child Labour, and cross-cutting issues like Child Participation and Children with disability. of SLARTC, played a pivotal role in guiding the discussions and facilitating a comprehensive approach towards addressing these challenges.

Eminent speakers, including Dr.

Samir Chaudhuri, Founder Secretary of CINI, Mr. Sarfraz Ahmed Khan, Associates Professor at NUJS, Ms. Baitali Ganguly, Secretary of Jabala, Dr. Jyotsna Jalan from CSSS, and Dr. Shubhrajyoti Mukherjee from Samikshani, shared their invaluable thoughts and guidance.

The event aimed to collaborationandsynergyamongdiverse stakeholders, ultimately striving for a brighter future for children. Mr. Sanjay Gupta, the Chairperson of NACG EVAC India, addressed the members online, emphasizing the importance of collective efforts in achieving child protection goals. Child in Need Institute (CINI), as an active participant in this initiative, demonstrated its commitment to the cause. The event underscored the significance of coordinated action in addressing the multifaceted challenges affecting children and echoed the collective determination to work towards a brighter and safer future.

### A SUMMIT FOR COLLABORATIVE ACTIONS FOR A SECURE FUTURE OF CHILDREN

In a significant initiative towards securing the future of children, a state-level stakeholder's consultation, titled "Samagam 23", was organized in Lucknow, Uttar Pradesh on 19th November 2023. This collaborative effort, spearheaded by NACG-EVAC India in collaboration with Safe Society, aimed to address crucial issues concerning child welfare. The summit provided a platform for discussing and formulating strategies for the holistic development of children, with a particular focus on child education, combating child labour and trafficking, child health and nutrition, and addressing the challenge of child marriage.

The summit's agenda encompassed several pivotal topics, reflecting the multifaceted nature of challenges faced by children. One of the core discussions centered around "Combating Child Labour and Trafficking: Strategies, Challenges, and Collaborative Solutions." Stakeholders deliberated on effective measures to eliminate child labour and trafficking, identifying challenges and formulating collaborative solutions to address these issues comprehensively.

Another crucial area of focus was "Child Health and Nutrition: Priorities,

The consultation featured presentations, discussions, and activities involving 42 children from 12 NGOs who actively engaged in proposing recommendations to combat environmental degradation in Delhi, focusing on topics such as waste management, the impact of climate change

on education and health, and measures to address air pollution.

In the breakout sessions, children passionately articulated their thoughts and concerns, emphasizing the need for stricter enforcement of environmental protection laws, increased citizen participation, and inclusion in the formulation and implementation of laws addressing environmental concerns. The consultation concluded with the selection of a child elected democratically representative, by their peers, who will represent their collective voice at the National Consultation on Children's Rights to Environment and Climate Change in Kolkata. The event highlighted the significance of considering children's perspectives in addressing environmental challenges and the urgency of collaborative efforts for a cleaner and sustainable future.

In the concluding remarks, Smt. Manisha Bhattacharyya, the Additional Labour Commissioner, underscored the profound impact of child labour on physical and mental well-being, calling for a nuanced, comprehensive approach.

The session concluded with gratitude expressed by Ms. Lena Dasgupta, accompanied by Rabindra Sangeet, leaving an inspirational resonance. The consultation served as a crucial platform for collaboration and discourse, fostering a collective commitment to combat child labour and ensure the well-being of every child.

#### RWAs to help govt check child labour

New Delhi: With a number of cases of people employing children as domestic help and to turing them coming to light, the Delhi government has decided to engage with resident welfare associations to check child labour.

The labour department has issued an advisory to RWAs to sensitise people to avoid employing underrage boys and girls as domestic workers. The government has also advised people to check if the placement agency through which they hive domestic help is registered. A senior Delhi government official said employment of child labour was not only a social and economic menace but was also prohibited under Child and Adolescent Labour (Proventiorand Regulation) Act, 1986, Juvenile Justice Act mits, and Delhi Private Placement Agencies (Regulation) Order, 2014.
